Intermediate NDT Handling and Problem-Solving Course

COURSE DESCRIPTION

This course is designed for PTs, OTs and SLPs who have taken one or more introductory level courses in pediatric NDT, and are seeking to improve their critical problem solving skills, increase their treatment repertoire, and increase their confidence and skill in treatment. The class will be very movement-focused, with emphasis on movement sessions with other participants, as well as guided practicum time with children who have cerebral palsy or similar neurologically-based diagnoses.

COURSE OBJECTIVES

- Understand more fully many of the various components of typical development of movement and posture, and how they differ from those of children with cerebral palsy.
- Develop better clinical problem solving skills and more effective treatment plans for children with cerebral palsy of various types and distribution.
- Increase repertoire of clinical handling skill for advancing motor skill development in children with neuromuscular involvement.
